



ACSA EDUCATIONAL AWARDS APPLICATION FORM 2022

A. Introduction

The Association of Certified Security Agencies (or ACSA) has decided to launch the ACSA Educational Awards 2021. We are glad to announce and say that we will be inaugurated again on 16 March 2023.

The award in the form of book prizes aims to support deserving children of financially constrained security officers and other staff employed by ACSA members.

This year the ACSA Education Awards will be given to 30 students only.

B. Appointment of Educational Awards Committee (EAC)

ACSA Executive Committee has appointed an EAC to –

- Decide on categories of awardees
- Determine the types of awards
- Receive, evaluate, and decide on the deserving awardees; and
- See to the planning and implementation of the presentation of the awards.

The decision of the EAC shall be final. No form of appeal will be received and entertained.

C. Eligibility Criteria

1. Applicants –

- Any child of a security officer or supporting staff, who are employed by a member of ACSA.
- The applicant's parent must have been employed by a member of ACSA for at least twelve (12) months as of 1st August 2022. The date of employment must be on or before 1st September 2021.
- The applicant must be a Singapore Citizen / Permanent Resident. Documentary evidence of the relationship must be included in the application.

2. The applicants must be Full-time / Part-time students in Government or Government-aided Schools and Institutions of Higher Learning.

- Primary School
- Secondary School
- Specialised School
- ITE
- Junior Colleges / Millennia Institute
- Polytechnics

3. There is **NO limit** to the number of applicants from each family.
4. The completed application form must be submitted to:
Secretariat ACSA, c/o 33 Sam Leong Road, Singapore 207923, on or before 17 February 2023 (Friday) . **Do take note application forms submitted after the closing date will not be considered.**

D. Type of Award

1. Book Prize

a. The ACSA Book Prize will be awarded to financially constrained applicants, who demonstrate academic excellence, strong leadership qualities and passion to fellow students.

b. Book Prize comes with a Certificate and cash award, as follows:

i.	Primary 5 and 6	\$200
ii.	Lower Secondary	\$300
iii.	Upper Secondary	\$350
iv.	Specialised Schools / ITE	\$450
v.	JC / Millennia Institute / Polytechnic	\$600

E. Disqualification

An application which is incomplete, containing inaccurate or false information shall be deemed to be void.

F. Attendance at the Presentation Ceremony

Successful applicants who are full time students must attend the presentation ceremony in their school uniforms. Those who are in Polytechnics must be dressed formally in a shirt / blouse and pants / skirts.
